Education, Health and Care Plan (EHCP) timetable

<p>The local authority (LA) receives a request for an EHC needs assessment. The authority must tell parents about this request.</p>	<p>The date the authority received the request is the start date.</p>
<p>The local authority decides if an EHC needs assessment is necessary. The authority must tell parents about its decision.</p>	<p>Within six weeks of the start date.</p>
<p>If agreed the EHC needs assessment takes place.</p> <p>The local authority tells the parents of its decision. <i>Either</i> The local authority sends a draft EHC Plan to parents. <i>Or</i> The local authority tells the parents of its decision not to issue an EHC Plan. Your letter from the authority will explain what you can do next.</p>	<p>This assessment starts as soon as the decision is made.</p> <p>— Within 16 weeks of the start date.</p>
<p>Parents should respond to the draft EHC Plan. They can: Agree that the draft is adequate or ask for a meeting to discuss any changes.</p> <p>Parents have the right at this point to state a preference for a school or early years setting.</p>	<p>Within 15 days of receiving the draft EHC Plan.</p>
<p>The local authority consults with the school or early years setting.</p>	<p>Within 15 days of parents' response to the draft EHC Plan.</p>
<p>The local authority issues the final EHC Plan.</p>	<p>Within 20 weeks of the start date.</p>
